In dealing so, the Internal Committee (Sexual Harassment) shall comply with the procedure prescribed in the regulations for making a complaint and inquiring into the complaint.

**Where and Whom to Lodge a Complaint:**

If you are a victim of sexual harassment or perceive yourself to be, immediately contact (personally or through telephone / written request / e-mail) any of the committee members of the Internal Committee (sexual harassment).

The Internal Committee (sexual harassment) shall ensure that the complaint is kept totally confidential, and adequate protection will be provided to the complainant, whenever and wherever necessary. Complaints shall be heard expeditiously while adhering to the principle of natural justice.

Necessary recommendations will be made to the competent authority on the basis of the findings of the inquiry by the members of the committee.

This notification is issued with due approval from the competent authority.
