

Where and Whom to Lodge a Complaint:

If you are a victim of sexual harassment or perceive yourself to be, immediately contact (personally or through telephone / written request / e-mail) any of the committee members of the ICC.

ICC shall ensure that the complaint is kept totally confidential, and adequate protection is provided to the complainant, where necessary. Complaints shall be heard expeditiously while adhering to the principle of Natural Justice. Necessary recommendations will be made to the competent authority on the basis of the findings of the inquiry.
