CODE OF ETHICS

The BITS Pilani Code of Ethics outlines the principles and guidelines governing the ethical conduct of all members within the BITS Pilani community. This policy aims to foster a culture of integrity, respect, and responsibility, ensuring that all actions and decisions align with the core values and mission of BITS Pilani.

Research and Academic Integrity:

1. Academic Integrity

- Uphold the highest standards of academic integrity, avoiding plagiarism, cheating, and any form of academic dishonesty.
- Promote a culture of academic honesty and fairness among faculty, staff, and students.

2. Academic Freedom and Freedom of Expression

- Respect and uphold the principles of academic freedom and freedom of expression.
- Encourage an open exchange of ideas, diverse perspectives, and constructive criticism to foster academic and intellectual growth.

3. Responsible Research

- Adhere to ethical and professional standards in all research activities, ensuring accuracy and honesty in reporting findings.
- Comply with ethical considerations and guidelines for research involving human subjects and animals.

4. Responsible Conduct in Peer Review and Academic Publishing

- Engage in ethical peer review processes, providing fair and constructive feedback to enhance the quality of academic publications.
- Emphasize ethical considerations in academic publishing to promote transparency and accuracy of research findings.

5. Protection of Human and Animal Rights in Research

- We uphold the rights and welfare of human subjects and animals involved in research, ensuring that proper consent and ethical considerations are followed in all research studies.

Administration and Governance:

1. Conflict of Interest

- Avoid situations where personal, financial, or professional interests may conflict with the best interests of the University.
- Promptly disclose all conflicts of interest to the appropriate authorities.

2. Compliance with Laws and Regulations

- Comply with all applicable laws, regulations, and institutional policies. Ignorance of the law is not an excuse for non-compliance.

3. Protection of University Assets
